
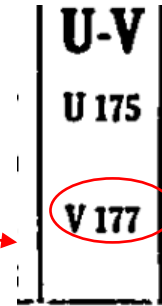



This Cott Key Table Index divides Names into Groups according to FIRST TWO LETTERS of SURNAMES (Martin-Ma) or FIRST LETTERS of First Principal Word of Corporation or Firm Names (The J. C. Brooks Mfg. Company-Bz) disregarding prefix "The". Groups start on front of numbered sheet, continue on back and on added sheets taken from back of book. Each added sheet should be numbered alike both sides, same as back of sheet it follows.

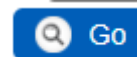

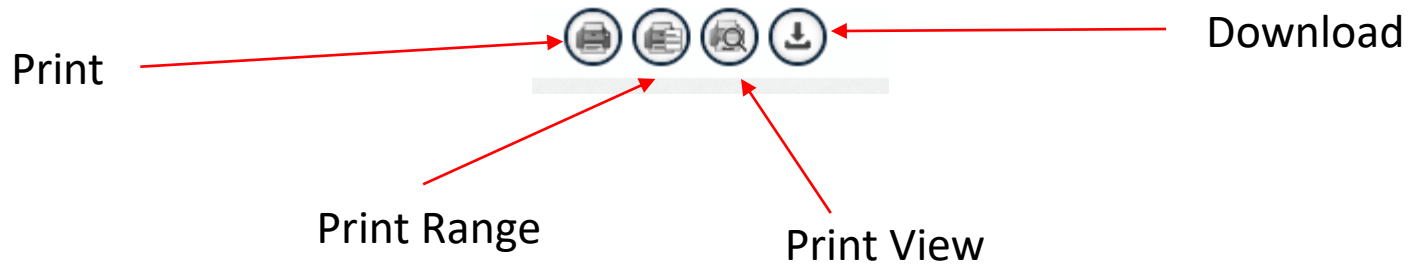
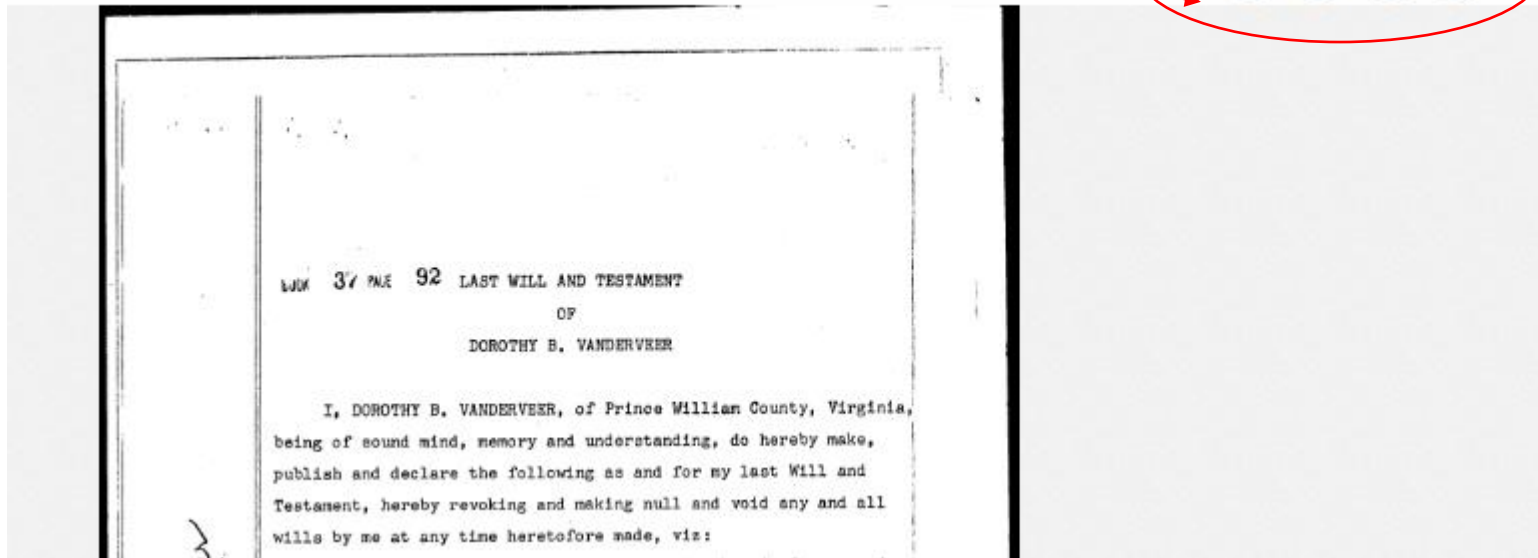
