

October is National Domestic Violence Awareness Month. Domestic violence can start with verbal abuse, controlling behavior, and threats, which could escalate further. Physical or sexual violence, stalking or psychological abuse can follow. These actions could be by a parent, sibling, spouse, or partner, which could begin to affect the person's life negatively. Domestic violence effects physical health, self-worth; and can lead to anxiety, depression, and feelings of helplessness.

Domestic violence affects millions of people in the United States each year. The CDC reports that:

- About 1 in 4 women and nearly 1 in 10 men have experienced sexual violence, physical violence, and/or stalking by an intimate partner during their lifetime.
- Over 43 million women and 38 million men have experienced psychological aggression by an intimate partner in their lifetime.
- 1 in 5 homicide victims are killed by an intimate partner. It was found that half of female homicide victims in the U.S. are killed by a current or former male intimate partner.

The CDC states that you are able to help the community by:

- Teaching safe and healthy relationship skills
- Be engaged with influential adults and peers
- Disrupt the developmental pathways toward partner violence
- Create protective environments
