Incidents

Attempted Armed Robbery – On April 4 at 7:06PM, officers responded to investigate an attempted robbery that was reported to have occurred at the 8000 block of Community Dr. in Manassas (20109) earlier that day. The investigation revealed the victims, a 16-year-old male juvenile and a 19-year-old man, were approached by an unknown man who brandished a firearm and demanded their property. The victims left the area before any property was taken. The suspect was described as a Hispanic male with a beard, wearing an orange ski-style mask, a black jacket, and black pants.

Arrests

Felony Neglect of a Vulnerable Adult – On April 2 at 9:01PM, officers responded to an area hospital to investigate the neglect of a vulnerable adult that reportedly stemmed from a call at the Bayvue Apartments located in the 14100 block of Fisher Ave. in Woodbridge (22191) earlier that day. The victim, a 32-year-old man, was initially brought to an area health care center on a medical call for general illness. Upon seeing the severity of the victim’s condition, hospital staff contacted the police. The investigation revealed the victim was in the care of a family member, identified as the accused, who had been failing to provide adequate care for the victim. The victim remains hospitalized in serious condition. During the investigation, a search warrant was executed at the apartment of the accused where detectives determined the neglect had been going on for an extended amount of time. Following the investigation, the accused, identified as Katharine Mary **THOMPSON**, was arrested.

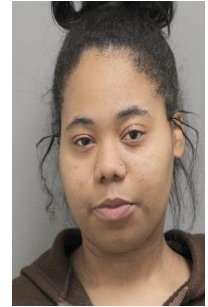

Assault & Battery on a Law Enforcement Officer [LEO] – On April 3 at 10:12PM, officers conducted a vehicle stop in the area of Oriskany Way and Constellation Pl. in Woodbridge (22191) for a traffic infraction. During the encounter, a woman from a nearby residence, later identified as the accused, began to interfere with the officer’s investigation. At one point, the accused grabbed an officer. The accused was detained without incident. No injuries were reported. Following the investigation, the accused, identified as Khiyya Mashai **SIMS**, was arrested.
