RE: ADOPTION OF THE PRINCE WILLIAM AREA CONSOLIDATED HOUSING AND COMMUNITY DEVELOPMENT PLAN FOR FISCAL YEARS 2006 – 2010 AND ANNUAL ACTION PLAN FOR FISCAL YEAR 2006

ACTION: APPROVED

WHEREAS, on July 1, 2005, Prince William County will continue to receive annual entitlement funds under the federal Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME) and Emergency Shelter Grant (ESG) programs to operate the Prince William Area's (Prince William County and the cities of Manassas and Manassas Park) housing and community development programs; and

WHEREAS, a condition of continued eligibility for receipt of these federal housing funds is that an entitlement community must submit to the U. S. Department of Housing and Urban Development (HUD) multi-year and one-year plans outlining its housing and community development needs, priorities and objectives, and proposed uses of funds for the ensuing program year; and

WHEREAS, the Prince William Area Consolidated Housing and Community Development Plan for Fiscal Years 2006 – 2010 and Annual Action Plan for Fiscal Year 2006 are the products of an ongoing collaborative process whereby the Prince William community has established a strategic vision for low- and moderate-income housing and community development actions, through the leadership of the Office of Housing and Community Development (OHCD) in cooperation with other County agencies and the private sector, and in collaboration with both Cities; and

WHEREAS, the Cities of Manassas and Manassas Park were consulted and provided ample opportunity for input prior to drafting the Prince William Area Consolidated Housing and Community Development Plan for Fiscal Years 2006 – 2010 and Annual Action Plan for Fiscal Year 2006; and

WHEREAS, newspaper notices, special meetings, public hearings and open comment period, required to solicit citizen input and feedback regarding the Prince William Area Consolidated Housing and Community Development Plan for Fiscal Years 2006 – 2010 and Annual Action Plan for Fiscal Year 2006, were done, including review and consideration of public comments received; and


