Efficiencies and Process Improvements

- Transitioned approximately 50% of volunteer utility accounts nearly \$45K savings annually
- Utilization of county accounting/purchasing system immediate access, enhanced financial accountability and control (8 of 11 companies trained)



Fiscal Year 2012 Major Initiatives

- Capital Improvement Projects
 - Renovation of Station 4, Gainesville
 - Reconstruction of Station 5, Nokesville
 - Reconstruction of Station 6, Coles
 - Construction of new Bacon Race F&R Station
- Medical Physical Budget to fund annual NFPA compliant physicals for all service providers
- Line of Duty Death Act requirement passed to locality from Statefunding for all service providers
- 5% Operating budget increase for all volunteer companies
- Collaboration on shifts between company operating budgets

Fiscal Year 2012 Budget Initiatives

- EMS Billing Program
 - Late Feb-Early March Meetings with Billing Company
 - March-April
 - policy & procedure development; agreements with hospitals
 - ◆Medicare & 3rd Party insurance enrollment
 - EMS Provider and program management training
 - ◆Information Technology interfaces
 - March-April Systems functionality testing; process validation
 - April-May Process verification, systems & data integration
 - May-June Begin billing for transport services



FRA EMS Billing Recommendations
